Andrew G. Pattillo, Jr. ("Pat"), 81, passed away Tuesday, November 2, 2010. He was born in Daytona Beach, Florida on February 8, 1929. He was a second generation Floridian. He graduated from Orlando High School, the University of Florida and the University of Florida College of Law. He married the former Mary Alice Herlong on September 5, 1953. They moved to Ocala in 1954 and became members of the First United Methodist Church. He served the Church in many capacities throughout his life. He practiced law in Ocala for over four decades. He was past president of the Florida Bar Foundation and a fellow in the American College of Trial Lawyers.
