Obituary of Anna Stumpo

Anna Raphaella Stumpo, The Villages, FL, died Thursday, December 20, 2012. She was born in East Orange, NJ and moved to The Villages in 2000 from Lighthouse Point, FL. She received her undergraduate degree from the College of Saint Elizabeth and a Juris Doctor from Seton Hall Law School where she was the only woman in her graduating class. She was also knighted a Dame of the Holy Sepulcher at the Vatican. Anna taught for several years for the Archdiocese of Miami and was very active in her parish of St. Elizabeth of Hungary in Pompano Beach, FL. She loved crafting, sewing, and was an avid Crimson Tide fan. She was the founder of The Florida Club in The Villages, a lifetime member of Beta Sigma Phi sorority, and a lover of dogs, especially her boxer, Tiger Lily. Anna was preceded in death by her husband of 32 years, Carmine "Chet" Stumpo in 1994. Survivors included a son, Carmine D. Stumpo; daughters: Maria Stumpo Shoff (Harry), Boca Raton, FL; Sue Ane Stumpo Brownell (Michael), Fruitland Park, FL; grandchildren: Samantha and Harry Shoff; step-grandchildren Justin and Stephen Brownell; great grandchild Alexander Brownell, Tampa, FL; brother Sabino DeRogatis (Sandra); nieces: Lisa Marie and Danielle DeRogatis.
