Obituary of Charles Lennon, Jr.

Charles Dennis Lennon Jr. passed away surrounded by family on December 07, 2016. Charles was born at Durham Young Clinic, Leesburg Florida to Charles and Evelyn Lennon on April 13, 1949. He attended Leesburg High School and graduated with the class of 1969. From there he operated heavy equipment for Paul Smith Construction as well as J.E. Hill Contractors. Later he spent many years at The City of Leesburg Electric Department where he retired to follow his passion in Law Enforcement. He worked days at The City of Leesburg Electric Department and spent nights as a Reserve Deputy Sherriff with Lake County Sheriff's Department at the same time he attended Lake County Vo-Tech where he earned his Law Enforcement Certification. Upon completion of his law enforcement classes he became a Deputy Sherriff working for Lake County Sherriff's Department. He spent the remainder of his working years with the sheriff's department, where he was assigned to the Agriculture and Marine Unit. He found his passion in the groves, pastures, and lakes of Lake County. Charlie was happiest helping round up a loose cow, searching for a lost boater, and helping farmers that were in need of law enforcement. Anyone that worked with him knew Patrol 201's voice on the radio. He retired from the Sherriff's Office in 2008. He was a lifelong outdoors man, spending most of his free time in the forest hunting deer or turkey. Charles is survived by his wife of 42 years Carla Lennon, Daughters:
