Obituary of Charles Rogers

Charles J. Rogers, 84, of The Villages, FL died on Monday, November 9, 2009. He was born in Roscoe, NY and was raised on a farm in Middletown, NY. He served in the US Army during WWII and the Korean War. After the service he worked as a Police Officer in Paterson, NJ until retirement in 1985. He moved to Florida in 1987 from Paterson, NJ and was employed as a security supervisor for Harbor Hills until he retired at the age of 73. He was a Past Commander of DAV Chapter 150, Orange Blossom Gardens; member of the Police and Fire Retirees Club, The Villages; a member of DAV Unit 87, Leesburg; American Legion, NJ; Life Member of Korean War Veterans Assoc., Inc.; and he was on the Civilian Review Board of the Lady Lake Police Dept.
