She married Elmer E. Northway Sept. 28, 1940. She is also survived by thirty grandchildren and forty-one great-grandchildren.

She was the first of five children two of whom survive: Jean Culligan, Indian

She recently moved to The Villages where she resided with her daughter Barbara and son-in-law Dr. Thomas Davis. She had been both a homemaker and professional with the Wisconsin Department of Social Services. She and her husband also owned a farm in Central Wisconsin for several years after moving from the suburban Chicago area. She and her husband retired to MN and later AZ. She returned to MN and recently to FL. Her husband preceded her in death in 1998. She was a lifelong Catholic and was a member of various parishes throughout her life.
