### Obituary of John Cox

John D. Cox, 70, The Villages, FL died Wednesday, February 15, 2012. He was born in Watertown, NY and moved to The Villages in 2003. He was a previous member of First Baptist Church in Watertown, graduated from Watertown High School in 1960 and attended SUNY Delhi. He was a General Manager of General Crushed Stone and retired in 1997. This position was previously held by his father and grandfather, dating back to Watertown Stone Products. John was a Town Justice for the Town of LeRay from 1978 until 2003. During his years as a Town Justice he served on the Board of New York State Magistrates, moving into the President's position for 2002. He was also an active member of Jefferson County Magistrates Board, serving in several leadership positions.

John enjoyed boating the St. Lawrence River, NASCAR, traveling and marrying couples as part of his magistrates duties. He also enjoyed golf and his part time courier job for Citizens First Bank after moving to Florida.
