William S. (Bill) Nimmons, 75, passed on November 12, 2011 in Tallahassee Florida after a valiant but brief fight with brain cancer. Bill was born on September 9th, 1936 in Columbia, South Carolina. Bill and Dot enjoyed life to the fullest and modeled a truly loving relationship to their children having been married for 54 years. Bill retired from the Navy, as a Chief, in 1974 and worked as a motorcycle repairman (riding motorcycles was one of his many passions) before settling into his second career in cable TV working for Tele-media and Adelphia. During this time, Bill and Dot just couldn't get the Navy way of life out of their blood and continued to move around the United States and lived in Wisconsin, North Carolina, Georgia and finally in Leesburg, FL until his passing. They made many friends along the way and enjoyed retirement to the fullest as they did the things they loved to do: riding motorcycles, square and round dancing, and camping with

their friends. Bill and Dot are members of the First Baptist Church of Leesburg. One of his first loves was Christian music.
